Australia's commercial tyre industry is entering a new era driven by sustainability, cost efficiency, and smarter fleet management. As demand rises across the logistics, mining, and agricultural sectors, precured tread technology is gaining momentum as a key solution supporting Australia's circular economy and long-term operational performance.

Approximately one-third of new truck tyre sales in Australia are accounted for by retreaded truck tyres, reflecting steady demand despite competition from low-cost imported tyres. Truck tyre casings can typically be retreaded two to three times, reducing raw material consumption and oil usage compared to producing new tyres.

Malaysia is rapidly emerging as a preferred supplier of precured tread materials to Australia, with exports increasing from RM12.2 million in 2019 to RM13.1 million in 2025, reflecting growing confidence in Malaysia's manufacturing excellence and sustainable solutions.
